## **RESOLUTION**

Whereas, the Local Tax Collection Law of the Commonwealth of Pennsylvania, 1945, May 25, P.L. 1050, Sec. 1, et. seq., 72 P.L. sec. 5511.1 et seq. provides that the commission or compensation to be paid to the tax collectors shall be determined by the Board of School Directors in the manner provided in said Act: and

Whereas, it is the desire of the Board of Directors of the Northern York County School District to require the tax collectors to deposit all tax monies collected for the District into a separate bank account established by the tax collector: and

Whereas, it is the desire of the Board of Directors of Northern York County School District to require the tax collectors to perform their duties in a manner as directed by the Board in order to enhance the efficient collection of school taxes.

NOW, THEREFORE, be it resolved, and it is hereby resolved as follows:

1. That the collectors of school taxes for the Northern York County School District shall be compensated thus:

For the period July 1, 2018, through June 30, 2019, and the three succeeding fiscal years thereafter: Tax collectors of the District will receive a salary for every year Real Estate Taxes and Per Capita Taxes are collected as follows:

Carroll Township:	\$ 14,547.80
Dillsburg Borough	\$ 5,657.20
Franklin Township	\$ 11,470.40
Franklintown Borough	\$ 1,205.20
Monaghan Township	\$. 6,600.20
Warrington Township	\$ 11,860.60
Wellsville Borough	\$ 649.00

The School Board may consider eliminating Per Capita Taxes at some point over the next four years. If this occurs, tax collectors of the District will receive a salary for every year that only Real Estate Taxes are collected as follows:

Carroll Township:	\$ 8,229.00
Dillsburg Borough	\$ 2,994.00
Franklin Township	\$ 6,432.00
Franklintown Borough	\$ 702.00
Monaghan Township	\$ 3,759.00
Warrington Township	\$ 6,873.00
Wellsville Borough	\$ 363.00

Payments will be made in equal installments over the year. There will be no additional payments for interim or installment bills.

Any tax collector that chooses not to run for re-election in 2021, or who is defeated in the 2021 municipal election, may elect to receive the balance of the compensation due them in a lump sum payment in either December, 2021 or January, 2022.

Such compensation includes all expenses except those specifically prescribed by law that the school district must pay, there being no further compensation or benefits for such services.

If the township tax collector changes during the fiscal year, compensation is paid for the position, not for the person or persons filling that position. Compensation will be paid to the person or persons on a pro-rata basis.

2. The tax collectors shall follow all policies and procedures as set forth by the Board of Directors. The Board of Directors reserves the right to make changes to policies and procedures at any time deemed necessary for the well being of the Northern York County School District.

This resolution shall be effective as of January 26, 2017, and shall remain in force and effect until repealed or amended by this School Board or its successors.
